Dear friends

Greetings everybody!

Our AGM was held in Copenhagen in co-operation with AOPA DMU. Minutes of the meeting will be distributed when completed. We had a nice meeting with rather many of our members on board.

The main topic we discussed is the future of AVGAS. This is not mainly an EASA issue, it will have an impact on all operators of aircraft equipped with traditional piston engines. As you may know, Tetraethyllead (TEL), a key component of AVGAS 100LL, is banned in the EU from 1/5/2025 onwards. TEL was added to "REACH" -list (EU chemical agency, regulating harmful substances). "REACH" stands for the Regulation on the registration, evaluation, authorisation and restriction of chemicals (REACH), it is the main EU law.

There is a substitute existing in the USA called G100UL. The product is developed by GAMI but they are not a manufacturer of the AVGAS.

At this point we unfortunately have more questions than solutions but we are doing our very best to get answers. We try to find out if there is anybody in Europe prepared to produce such a product. As soon as we get any information it will be distributed to you. One key issue might be that the G100UL has from our understanding few components that are not yet in this REACH list. This element could be the most problematic as I have no idea how fast the chemical agency researches new substances. But as said: When we have information, it will be told whether it is good or bad news.

Now, from my side I still have to thank once more the AOPA DMU for the good arrangements of the AGM.

We now have new vice-president, Martin Ryff, from Switzerland on board and we have now set up a Facebook page for EFPU. We try to use this channel also as a distribution channel together with this News Flash. Feedback from the member has been that this News Flash is needed and many are redistributing it to their local clubs. So, find us on facebook and remember to join!

I also just received during writing this letter an EAS newsletter. I attach this to this letter for those of you if not yet receiving the letter.

28/3/2023 ED Decision 2023/003/R 'Provision of rescue and firefighting services for General Aviation flights', covering the requirements to aerodromes. AMC and GM to Authority, Organisation and Operations Requirements for Aerodromes — Issue 1, Amendment 8 (RMT.0392)

Here follows the Agency's EXECUTIVE SUMMARY for ED 2023/003/R and 004/R

The objective of these Decisions is to improve the proportionality of the provisions on rescue and firefighting services (RFFS) for General Aviation (GA) flights by incorporating the related amendments to International Civil Aviation Organization **(ICAO) Annex 6, Part II, and Annex 14, Volume I** into the EU regulatory system. These Decisions amend the acceptable means of compliance (AMC) and guidance material (GM) to Regulations (EU) Nos 139/2014 ('Aerodromes Regulation') and 965/2012 ('Air OPS Regulation'). They provide guidance to aerodrome operators on how to apply the requirements for the provision of RFFS for GA flights and introduce an acceptable means to disseminate related information to flight crews and GA operators. Furthermore, the Decisions increase the availability of aerodromes for NCC, NCO, and SPO operators by using a risk-basedapproach when deciding whether an aerodrome is acceptable in terms of adequacy of its RFFS. The Decisions also correct some editorial errors that were introduced by ED Decision 2022/013/R. The amendments are expected to maintain safety and, at the same time, increase cost-efficiency for aerodrome operators by reducing the costs for establishing and/or maintaining RFFS for GA flights. Moreover, it is expected that GA pilots will have access to more aerodromes, which in turn **will lead to flight efficiency and reduce the related flight costs.**

We read: "The internal rules of the ICAO, in particular those which cause the latest versions of documents for decisions regarding new SARPs or amendments to SARPs **to be available** to the ICAO Council **only late**, the deadlines set by the ICAO for ICAO Contracting States to notify differences with respect to international standards, as well as **the sheer number of differences in the areas of civil aviation safety, air navigation and air traffic management to be notified each year**, make it difficult to establish the position to be taken on the Union's behalf in a Council Decision based on Article 218(9) Treaty on the Functioning of the European Union in a timely manner for new SARPs or amendments to SARPs to be adopted, or for each difference to be notified."
