The European Union Aviation Safety Agency (EASA) and the European Centre for Disease Prevention and Control (ECDC) have decided to formally retire the EASA-ECDC joint Aviation Health Safety Protocol (AHSP), while acknowledging its significant value during the high SARS-CoV-2 circulation periods during the pandemic. - Amendment 22 (ED Decision 2021/007/R) on ageing aircraft structures; and
- Amendment 23 (ED Decision 2022/001/R) on a regular update of AMC-20.
